Choosing A Freight Auditor

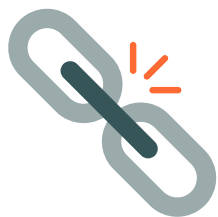

WHAT TO LOOK FOR IN A FREIGHT AUDITOR



1 A Partner – Not a Service Provider – That Enables Comprehensive Supply Chain Management

Your business needs and supply chain requirements are not one-size-fits-all, and your freight auditor and analytics company shouldn't approach them as such. Unlike a service provider with a single standard solution, choose a company that will partner with you to understand your custom processes and tailor their tools and services to achieve your goals.

A customized solution that fits your specific business can be implemented with minimal disruption to your operations, as well as effectively manage your own distinctive supply chain processes – from payables, data auditing and freight analytics through to supply chain decision-based modelling. Look for a freight auditor that will hold quarterly business reviews, walk you through year over year comparisons and is willing and able to run scenario modelling, such as projecting cost savings if you moved a DC to another city. Ensure they have the foresight, scalability and proven expertise to help predict and meet your future business requirements.

The freight supply chain is filled with variables and complexity, from the calculation of density and rates to accessorial charges, fuel surcharges, taxes by state/province and much more. The freight audit and analytics solution you choose can make the difference between profit and loss on each shipment – so choose wisely.



2 Provides End-To-End Invoice Review, Payment Processing and Discrepancy Resolution Services

Good freight audit and analytics technology saves valuable FTE (full-time employee) time by automating freight audit processes, such as data collection, data cleansing, invoice review, payment processing and supply chain reporting. The software delivers significant freight cost savings by correctly classifying the freight; verifying the base rate; ensuring that local taxes reflect current laws; checking that relevant fees, tariffs, discounts and accessorials have been applied; providing an audit trail and confirming that the final amount is accurate before processing your payments. A good freight auditor will have multi-jurisdictional capabilities to comply with the laws, tariffs and taxes in all your current and future jurisdictions. But here is where you separate a good freight audit and analytics solution from a great one. A great one will ensure you never again pay for your carriers' billing mistakes, because they employ the best experts who work with your carriers to solve discrepancies and request credits on your behalf, saving your team valuable time and money.



3 Has Invoice Consolidation Capabilities

If you're not working with consolidated invoices, you're paying too much. Consider the mountains of paperwork involved in a busy shipping operation. 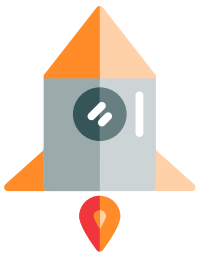

The best providers can work with any enterprise resource planning (ERP) solution, warehouse management system (WMS) or in-house software. Onboarding new systems and processes are time consuming but imperative to improving your supply chain and transportation networks, so choose a company that will take on the heavy lifting. At the same time, they should consult with you on a regular basis to set goals and ensure that processes, rules, rate agreements and other essential elements are aligned with your operation and requirements.



6 Forward Looking and Continually Reinvesting In Technology

Technology – backed by solid processes – is the key driver for creating a more efficient supply chain. Look for a freight auditor that is continuously reinvesting in technology to provide real-time insights that help you realize efficiencies, calculate potential savings opportunities, predict trends and manage costs. Make sure they offer a mobile app so you can access and respond to critical data from anywhere at any time. Ask if they are investigating new ways that technology can serve you, including the use of AI (artificial intelligence) and ML (machine learning). Why? AI and ML are enabling freight audit companies to recognize and track patterns in shipping so they can recommend lower cost options, such as shipment consolidation programs or DC location changes. AI can also provide predictive intelligence so your freight auditor can get to know your customer demand data and help you make better decisions to reduce your bottom-line distribution costs.

Ultimately, you want to work with a freight auditor that is always thinking ahead to what the market will need in the future. If in doubt, ask prospective companies what their technology capabilities will be in the next 2-5 years. 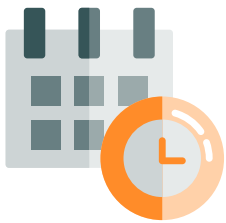




7 Has Multiple Carrier Relationships

8 Handles RFP Response

Carrier selection should never be based on price alone. Choose a freight auditor that handles RFP responses as if their own business depended on it – comprehensively outlining a carrier's capabilities and terms of service, as well as its pricing structure.

Conversely, to provide an accurate response, carriers will need to understand your general shipment frequency, volumes, delivery windows, lead times, pickup days, typical shipment attributes – including weight, size, type of packaging, value – and much more. So when carriers request it when bidding on freight annually, it can be quickly compiled and provided in standard formatting to all carriers. Your team will simply need to fill in dates, regions and the carriers they want to include. From there the freight audit and analytics software will quickly create and issue an RFP package that would have taken your operations director 20-40 hours to compile and prepare. Time is saved, the RFP process is simplified, and favourable and realistic responses have come in because the information carriers received was based on concrete historical data.
